

1. <u>Presentation by DBDriven -</u> DBDriven Technical Support Team - presented to the DGC on the eMPowerED ecosystem, Customer Relationship Management (CRM) system discussing roles and access, and data protections in a federated system. A demonstration was done on agency access of the portal and examples of how matching is done in the back end. The presentation ended with next steps which included identifying agency contacts, agency data transfer and the matching process.
