## **CNMI Youth Management Office**

**PROPOSAL:** Seeks to share student engagement and case tracking data with the SLDS

#### **SLDS Review:**

- -Findings: Strong mission alignment with SLDS goals
- -Concerns: Data is stored on spreadsheets; no secure system or export process.
- -Feedback: High strategic fit, low technical feasibility. Infrastructure must improve before proceeding.
  - -Decision: Invite to Self-Assessment with caution flag.

#### **Agency Review:**

- -**Findings:** Agency confirms lack of system and no data steward. Expresses willingness to build capacity.
  - -Feedback: Agency is highly engaged, but lacks core prerequisites for safe integration.
  - -Decision: Recommend delay and target technical assistance.

**PROPOSAL:** Proposes sharing youth employment outcomes with the SLDS to improve transition tracking.

#### **SLDS Review:**

- -Findings: Strong policy fit; minor questions about data stewardship
- -Feedback: Seems viable. Self-Assessment will help clarify readiness
- -Decision: Proceed to Self-Assessment.

#### **Agency Review:**

- -**Findings:** Agency admits to not having a privacy policy or data steward role formally assigned.
- -**Feedback:** Excellent transparency. Gaps are clear and solvable. Provided support tools and coaching.
  - -Decision: Recommend conditional approval with follow-up support.

**PROPOSAL:** A nonprofit coalition expresses interest in becoming an SLDS data partner to gain insight into school-to-career pathways for thier program planning and advocacy.

#### **SLDS Review:**

- -**Findings:** Strong interest; However, the agency does not own or steward any original datasets—they primarily convene meetings and provide outreach services.
- -Feedback: Important stakeholder, but not a data-owning entity. No technical infrastructure or governance over source data.
- -**Decision:** Flagged as non-viable for integration but worth involving in strategic conversations. Not invited to Self-Assessment.
